



Chains in focus

Inspection of fork lift chains and measurement of chain elongation has always formed a major part of Thorough Examination. It is an area in which we can demonstrate a lead over other organisations carrying out inspections or technical audits. Indeed, both BITA and the FLTA publish definitive guidance and technical information on the inspection and maintenance of industrial truck leaf chains.

You should certainly be aware that chains with a measured elongation of 3% or more must be **RENEWED IMMEDIATELY** and the lift truck removed from service until the chain has been replaced. For chains with 2% or more elongation a judgement needs to be made on whether or not the chain can continue to be used safely up to the next Thorough Examination. It must also be remembered that this is not the only part of the chain that needs to be examined. The Competent Person should also visually inspect the chain anchor points and look for any of the following problems in associated components:

- evidence of pitting or corrosion
 - missing link plates
- I cracked or missing links
- loose pins with enlarged pin holes

It is also important to be aware of the chain link plate depth. Chains that have plates worn in excess of 5% must be **RENEWED IMMEDIATELY** and the lift truck removed from service until the chain has been replaced.

We are often asked what is the procedure when measuring chain elongation on metric chains. Since the FB Chain Gauge and other gauges only measure in imperial units, it is essential that the Competent Person converts the metric dimension into imperial. BITA Guidance Note GN15 and FLTA Technical Bulletin 14 both include conversion charts. Of course, this does not preclude the inspection being carried out using a metric rule.

How to enter


Entering is simple and straightforward, and only takes a few moments, using the official entry form on the IMHX website.
